The person that prepares WM reports for CTSWDD said that the entry listed as B14M is new, should have been in past reports and will now be part of all future totals. President Berry will ask Vaughn Kuerschner, Public Sector Representative from Waste Management, to supply details on this addition and depending on reason for this change may ask that all totals for prior months/years be adjusted since CTSWDD created reports comparing totals for 5 years.

Ms. Ballot asked how rain affects the overall tonnage. President Berry will ask Vaughn Kuerschner, Public Sector Representative from Waste Management about the effect of rain on tonnage.

ii. Missed Pick-Up, Complaints and Unresolved Report

There was one outstanding issue where a driver was reported to have inappropriate behavior but the follow-up did not report the action taken by WM. President Berry will ask Vaughn Kuerschner, Public Sector Representative from Waste Management, to supply more details on this incident.

According to Vaughn Kuerschner, WM, due to system limitations they are not able to pull the information for the report at his time. It is a future system enhancement but there is currently no target date.
