## 2. Monthly Reports - Waste Management Data

## i. Tonnage Report

Trash, Recycling and Yard Waste volume was slightly higher than the YTD average for 2015 and higher than the low September tonnage while still lower than the May – August 2015 tonnage.

We reviewed a new tonnage report by route for 2015. This report showed the addition of route B14M in June. The addition of the B14M route tonnage is offset with a decrease in the allocated tonnage.

We still need Vaughn Kuerschner, Public Sector Representative from Waste Management, to supply details on this additional route. We still need to understand why the September 2015 tonnage was so low.

# ii. Missed Pick-Up, Complaints and Unresolved Report

There were 30 issues reported, none of which need further follow-up by CTSWDD or WM.
